MESSAGE FROM OUR CHAIRMAN

South Africa is a country with a unique dynamic. For RAMOT as an NGO (a rehabilitation centre for substance dependence) the challenges are overwhelming to deliver a sustainable and affordable service that our patients and business partners/ stakeholders came to expect.

The challenging and competitive environment in which RAMOT operates puts further pressure on the organisation, especially when taking into consideration the various private rehabilitation centres which are supported by a strong financial basis.

RAMOT made a paradigm shift from "saving" to "innovation", upon which I elaborate:

- In November 2023 and February 2024, RAMOT undertook an information roadshow to various rural areas. The aim was to empower people with practical information and tools in relation to
 - dealing with addiction, to create awareness as to the various symptoms indicative of addiction and to leave a tangible footprint of RAMOT. The roadshows were attended by numerous social workers, municipal managers, church and community leaders. The feedback was overwhelmingly positive.
- RAMOT makes an effort to build networks with municipalities and other non-profit organizations. Ministers Sharna Fernandez and Jaco Londt (former and current Ministers of Social Services of the Western Cape), expressed their appreciation in writing for this initiative.
- A large billboard adjacent to the busy Frans Conradie Drive thoroughfare generates additional funds for RAMOT.
- RAMOT is giving serious consideration to the possibility of service delivery outside our national borders.
- A demand for programs completed over a longer period of time has been developed and implemented.
- RAMOT's finances is considered to be satisfactory (refer to Mr Koos van Tonder's financial report). In terms of finances, building and maintaining strong relationships with role players are of paramount importance.

A heartfelt thank you to our Program Manager, Mr Johannes Janse van Rensburg and his team for their commitment, innovation, energy and passionate service delivery. We as Governing Board are very proud of our staff. TREASURER'S REPORT



FINANCIAL REPORT FOR THE YEAR TO 31 MARCH 2024

Overview

Although RAMOT strives to charge fair fees for services, provision is made in the financial planning for a small surplus to maintain the necessary reserves. Of course, this is not possible every year and the financial result for the year under review, which shows a deficit of R175 000 (2% of Operating Expenses), is still more than satisfactory.

Expenditure

The cost of professional staff and outsourced professional services for non-governmental organizations (NGOs) remains a challenge due to the ongoing extraordinary increase thereof, measured against inflation, that NGOs experience. RAMOT manages these costs in a responsible manner so that the level of service to which RAMOT are committed to, can be continuously maintained. Constant oversight and stewardship are exercised over controllable expenses and management deserves to be applicated for their ingenuity which often results in savings.

Income

There is little that RAMOT can do about the fee structure. The State Subsidy and Medical Fund rates are determined externally. RAMOT is not in a position to adjust it upwards. Given the strong competition experienced in the market for private patients, it is also difficult here to adjust rates upwards if circumstances require it. Several projects are already underway, and management is positive that this will contribute to more patients using RAMOT's services despite the above limitations. The investment portfolio is invested conservatively and has a low risk profile. The income that flows from this makes an important contribution to financial sustainability.

Financial Statements

The summarized income and balance statements below, shows further information regarding the financial results for the past year.

RAMOT's financial position are sound, and the Governing Board would like to convey its thanks to management for their dedicated and responsible management of RAMOT's finances.

THE CENTRE

Our passion and focus is a multi-professional treatment program with a holistic approach. Ramot treats various forms of dependence, including alcohol, prescription medication and all other drugs. The main goal is to enable patients to recover physically, mentally and spiritually so that they can function optimally according to their true potential. A distinguishing feature of our program is the intensive personal attention that each patient receives.

Ramot was founded in 1964 to offer treatment to individuals and families faced with addiction problems. The centre currently has 40 beds with separate facilities for male and female patients. The centre follows a multi-disciplinary treatment programme, which is based on scientific research and implemented by specialist staff.


ADMISSION CRITERIA

PATIENT DEMOGRAPHICS





Minister Londt visited Ramot - one of five registered in-patient facilities subsidized by the DSD. Ramot provides in-patient treatment that consists of detoxification and five weeks of therapy. Here, Denver van der Bergh, a former patient shared his story.

Mr Van Der Bergh was addicted to alcohol and drugs for over 20 years before his employer intervened in 2020 and assisted him to go to Ramot for treatment. He has successfully abstained from drugs and alcohol since completing the treatment, has earned a business degree, landed a job in finance, and recently successfully completed his first Comrades Marathon.

"Ramot has walked this journey with me, even after I completed the <u>programme</u> in 2020. They sponsored my Comrades journey. Running has played an integral role in my rehabilitation. To those battling with addiction: there is always hope, it is never too late. Please make that change, you will be so happy, there is so much more to life," said Mr Van Der Bergh.

"Denver's story is not only a story of incredible perseverance and hope but is also proof that registered programmes work in turning lives around. We know and trust Ramot's processes, because they abide by the national and provincial legislations, norms, and standards, which gives peace of mind to clients like Denver – as well as their families," added Minister Londt.

Dear Johannes.

I trust this email finds you well. I am writing to express my sincere appreciation for the recent roadshow conducted by the Ramot Treatment Centre. This event has proven to be a pivotal factor in enhancing service delivery in the field of substance abuse treatment and empowering the communities. It is worth noting that this roadshow marked the first of its kind in the last 12 years, signifying a remarkable milestone for our initiative.

The level of professionalism and organization demonstrated throughout the roadshow was truly commendable. Ramot's commitment to providing high-quality information and training sessions showcased their dedication to improving substance use disorder (SUD) services in our province.

The Western Cape Department of Social Development's overarching purpose, through the Provincial Substance Abuse Forum (WCSAF), Local Drug Action Committees (LDACs), and the Substance Abuse program, is to design and implement integrated services for SUDs in alignment with the National Drug Master Plan 2019-2024. This comprehensive plan fosters coordination between departments, local authorities, and funded organizations, such as Ramot, in accordance with the Prevention and Treatment for Substance Abuse Act. no. 70 of 2008.

A key focus of WCSAF is to provide support to municipalities in establishing their LDACs. Once these committees are formed, they require capacitation on SUDs, referral pathways, psychoeducation regarding the biology of addiction, and guidance on working exclusively with registered facilities.

Ramot's roadshow in collaboration with the LDACs is pivotal in building the capacity of municipalities, their communities, and their stakeholders. This endeavour fills a crucial knowledge gap by providing widespread psychoeducation on addiction and SUDs, as well as guidance on the referral pathway to registered facilities.

Many stakeholders and communities across our province lack essential information about why it is crucial to know where, when, and how to seek help for SUDs. The recent roadshow with the West Coast municipality LDACs demonstrated that the information shared by Ramot was highly needed and empowering. Sessions on how to refer clients to Ramot and the importance of aftercare in the recovery process have made a significant impact.

By offering these critical capacity-building workshops to established LDACs, Ramot not only strengthens the network but also plays a pivotal role in breaking down barriers to treatment. This, in turn, promotes better access to treatment within a recovery-oriented system of care.

Given the remarkable success of the recent roadshow, I would highly recommend and request that Ramot continues this invaluable initiative with the Cape Winelands, Overberg, and Garden Route District Municipalities in the upcoming year, ideally in partnership with the Department of Social Development.

Once again, I extend my sincere thanks for the exceptional work undertaken by Ramot Treatment Centre. Your commitment to enhancing our province's substance abuse services is truly commendable.
